#### **6. Data Retention**

We retain data for as long as:

- Needed to fulfill legal or regulatory obligations.
- You maintain an active account or subscription.

#### **7. Data Sharing and Disclosure**

We do not sell your personal data. We may share data with:

- Service providers under strict confidentiality agreements.
- Legal or regulatory authorities where required by law.
- Partners only for the purpose of delivering Mailmentor services.

## 8. Security of Your Data

We implement security measures including:

- SSL encryption.
- Access control protocols.
- Regular system monitoring and audits.
- Encrypted backups and secure authentication.
